Recognitions

- The Board recognized Elida Zarazua, Administrative Clerk of the Plant Services Electrical and Mechanical Department. Mrs. Zarazua has dedicated over 50 years of service to SAISD. Mrs. Zarazua is a proud product of SAISD. She attended Burbank HS and graduated second in her class through the Business Program in 1966. Shortly after high school, she was hired in the Science Department where she typed curriculum guides for teachers. Two years later, Mrs. Zarazua served as secretary in the Safety Education Department and advised all campuses about the importance of school safety. Later, she worked in the Community Information Department, where she notified local TV stations and the community about upcoming Board Meetings, translated SAISD publications, and appeared on radio and television stations promoting exciting opportunities in the District. She also assisted the Superintendent's Office by transcribing minutes. In 1979, Mrs. Zarazua became secretary at Fox Tech High School. In 1995, she was hired in Plant Services as the administrative clerk of the Plant Services Electrical and Mechanical Department. The Board and Administration commended Mrs. Zarazua for her 50 years of dedication and continued service to SAISD.
- Trustees approved a resolution in recognition of Fire Prevention Week. The National Fire Protection Association has designated October 9-15, 2016 as Fire Prevention Week. This year's theme, "Don't Wait Check the Date! Replace Smoke Alarms Every 10 Years" effectively serves to remind us that we need working smoke alarms to give us the time to escape from a fire safely. This resolution serves as the Board recommendation to support the mission of providing fire safety education to SAISD students. To aid in this effort, the Edison High School Fire Science Program has committed to providing fire safety presentations at all SAISD elementary campuses. The students in the Fire Science program are accompanied by SAISD's very own "Sparky the Bear", who helps bring fire safety awareness to our youngest learners. Fire Prevention Week was established to commemorate the Great Chicago Fire in 1871 that killed more than 250 people, left 100,000 homeless, destroyed more than 17,400 structures and burned more than 2,000 acres.

2015-16 State Accountability Ratings Presentation

The Board received a presentation on the 2015-2016 State Accountability results from Theresa Urrabazo, the District's Executive Director of Accountability, Research, Evaluation and Testing. The District and campus State Accountability ratings along with the HB 5 Community and Student Engagement requirement were provided. The State Accountability report measured four performance indexes that include student performance, student progress, closing performance gaps and postsecondary readiness. SAISD was rated "Met Standard" for the 2015-2016 school year. Of the SAISD schools – 34 "Met Standard with Distinction," 36 "Met Standard," and 20 schools were identified as "Improvement Required." In addition, three schools achieved all possible Distinction Designations: Young Women's Leadership Academy, Baskin ES and Huppertz ES. Students were tested in reading, writing, math, science and social studies. Lisa

Riggs, Associate Superintendent of Curriculum & Instruction, added to the presentation with a summary of significant changes that SAISD is making in order to support schools with some of the challenges that have been discovered. The plan includes an emphasis on student and teacher support. The report showcased four core systemic challenges which includes organizational learning, curriculum development, instructional practices and instructional resources.

SAISD Legislative Priorities Approved

Trustees approved the legislative priorities SAISD will focus on during the 85th session of the Texas Legislature, which convenes Tuesday, January 10, 2017. Seth Rau, the District's Legislative Coordinator, presented a report to the board. The presentation emphasized five goals that were identified by the Board's Governance Committee as the primary legislative goals for SAISD in the upcoming legislative session. The goals are as follows: Ensure A-F is a Fair Accountability System; Create an Equitable School Finance System; Defend the District of Innovation Flexibilities; Invest in Early Childhood Education; and Fund College/Career Readiness Assessments.

SAISD Board Goals Approved

Trustees approved the 2016-2017 SAISD Board Goals. On August 8, 2016, the SAISD Board of Trustees held a Board work session to discuss their goals for the 2016-2017 school year. Their goals are as follows: 1. SAISD students will have access to higher education and career exploration opportunities. 2. SAISD students will be at or above grade literacy levels. 3. SAISD will increase the engagement of student's families and the community as active partners in the education. 4. SAISD students will have access and opportunities to participate in 21st century enrichment programs to enhance their education. 5. SAISD students will excel in high quality STEAM programs.
