Andrea Lucas Recognized for being Teacher of the Year

Trustees recognized Andrea Lucas, 4th grade teacher at Lamar ES, for being named the "Teacher of the Year" by the Education Service Center Region 20. She is one of six finalists for 2018 Texas Teacher of the Year. This honor places her in the running for Texas Teacher of the Year, the highest honor the State of Texas can bestow upon a teacher. Since 1969, the Texas Teacher of the Year (TOY) Program has honored excellence in classroom education and provided a forum to showcase many outstanding educators whose efforts and example have inspired their students, their colleagues, and the communities they serve. Facilitated by the Texas Association of School Administrators (TASA), the Texas TOY Program annually recognizes and rewards teachers who have demonstrated outstanding leadership and excellence in teaching.

Recognitions

- The Board recognized Jorge Garcia Navarro, of Edison HS, as the 1st Annual Salsa Contest winner. The Child Nutrition Services hosted its first Annual Salsa Competition on May 10, 2017. A total of 20 teams (individuals and groups of students) from the following high schools participated: Brackenridge, Sam Houston, Edison, Lanier, and Burbank. Students were challenged to create a "traditional" salsa recipe appropriate for grades K-12. Mr. Garcia's winning recipe will be served in all SAISD schools during the 2017-2018 school year.
- SAISD Board President Patti Radle administered the Oath of Office to new commissioned police officer Flor Koch.

SAISD Unified Enrollment Initiative Presentation

The Board received a presentation on the proposed 2017-2018 Unified Enrollment Initiative. Mohammed Choudhury, Chief Innovation Officer, provided the report. Under the District's Office of Innovation, the newly established Office of Access and Enrollment Services will oversee the design and management of the District's student enrollment processes (i.e. annual student registration procedures, school choice systems and parameters, and student transfer guidelines). This new initiative is specifically designed to improve current enrollment practices and procedures. The goal is to make the enrollment process a "one stop shop", streamline existing systems, optimize customer service, empower families, and to increase opportunities for families/students to access "best-fit schools", regardless of academic abilities and/or geographic constraints.

Policy Revisions Approved

Revisions to Board Policy DIA (LOCAL), FFI (LOCAL) and FFH (LOCAL). These revisions
include language prohibiting discrimination and harassment against employees and
students on the basis of gender identity, gender expression, and sexual orientation. Other
large urban districts such as Houston, Dallas, and Austin have also included this language
in their policies.
