# Final Amended Budget for Fiscal Year 2021-2022 Approved

The Board approved the final amended budget for fiscal year 2021-2022. This budget includes the General Fund, Child Nutrition Fund, and the Debt Service Fund. The San Antonio Independent School District amends the budget on a monthly basis as needed, and the budget may not be amended after June 30, 2022. Amended budget amounts are reflected in the Comprehensive Annual Financial Report (CAFR) in the "Schedule of Revenues, Expenditures, and Changes in Fund Balances", a report that compares the budget and actual expenditures for the year.

# Adoption of 2022-2023 SAISD Budget

Trustees adopted the 2022-2023 SAISD Budget. The General Fund budget proposed for adoption includes the following local budget in support of the State's Teacher Incentive Allotment (TIA) compensation plan for designated teachers. This same amount will be received as Foundation School Program revenue, so there is no cost to the District for the TIA stipend described below:

• Total TIA Budget included in Proposed 2022-2023 General Fund Budget: \$3,010,541

The Texas Education Agency requires that the School Board adopt an annual budget

on or before June 30<sup>th</sup> for the General Fund, Child Nutrition Fund, and Debt Service Fund for districts electing the July 1<sup>st</sup> fiscal year start date.

### SAISD Foundation Update

The Board received an update from the SAISD Foundation. This update provided highlights of the Foundation's activities over the past school year as well as financial statements from the 2021 external audit. As the Educational Foundation for the San Antonio Independent School District, the SAISD Foundation operates as a 501 (c) (3) public charity, with a mission to motivate the community to invest in students and teachers and a vision where all SAISD students and teachers thrive in San Antonio ISD public schools. The SAISD Foundation has invested nearly \$35 million over the past 15 years in educators' grants, student scholarships and emergency gap awards, and strategic investments in SAISD schools and district programs.

# Update on SAISD's Response to the Ongoing COVID-19 Crisis and Associated Expenditures

Trustees received an update on SAISD's Response to the Ongoing COVID-19 Crisis and associated expenditures. A report was presented by Toni Thompson (Associate Superintendent of Human Resources). The presentation focused on current case numbers, vaccine clinics, COVID testing sites, and updated guidelines from the Centers for Disease Control and Prevention (CDC).

### Technology Student Device Care Administrative Regulation Presentation

Trustees received a presentation on the updated Technology Student Device Care Administrative Regulation. In order for all students to consistently have updated, available, and operational devices to meet their instructional needs, the Information Technology Department has implemented several strategies promoting device care and accountability. One of those strategies is the proposed progressive accountability schedule which includes the possibility of a student being assessed a fee for not returning a device in an acceptable condition as defined below:

- The equipment is returned with the software and hardware in their original condition unless the school district authorized changes; and
- The physical condition of the equipment is fully usable as it was originally intended to be used.

# Selected Firm to Provide Redistricting Services Based on 2020 Census Approved

The Board approved the staff's recommendation to select the firm to provide redistricting services based on the 2020 Census. A Request for Proposal (RFP) 22-043 (RC) Redistricting Service was solicited during April 29, 2022 through May 19, 2022. SAISD received five (5) responses. The Evaluation Committee met on May 24, 2022, to combine scores and rank the firms. The Committee has selected Walsh, Gallegos, Trevino, Kyle & Robinson, P.C. to provide the best value proposal for redistricting services. The selected firm will determine the population variances between the seven single member districts based on the 2020 census data. Redistricting is based on population data from the 10-year census, which informs the state and local entities of

population imbalances within political districts. Texas Education Code Section 11.052 (i) requires the school district to "re-divide the district into the appropriate number of trustee districts if the census data indicates that the population of the most populous district exceeds the population of the least populous district by more than 10 percent."

### Contract with William Jupp for Consultative Services Approved

Trustees approved a contract with William Jupp for professional consulting services. Such services will include continuous school and community engagement and improvement of SAISD central office leaders, principals, and educators. Acquisition of this type of professional service is not legally subject to a formal procurement process. However, under CH (LOCAL), all professional services contracts of this value are typically subject to an appropriate competitive process. But, CH (LOCAL) also permits the Board to authorize the Superintendent, on a one-time basis, to acquire professional services without the use of an otherwise appropriate competitive process if the Board finds that it is in the best interest of the District.

# Interlocal Agreement Between SAISD and Uvalde Consolidated ISD for Sale of Four Unused Portable Buildings

The Board approved the Interlocal Agreement between SAISD and Uvalde Consolidated Independent School District for the sale of four (4) unused portable buildings. With the closing of Robb Elementary School, Uvalde CISD reached out to San Antonio ISD to inquire of any surplus portable buildings that the District would be willing to donate. These (4) portable buildings were previously used for swing space during the 2016 bond project at Rogers Middle School. With the completion of the 2016 bond construction, these portables are no longer needed at Rogers. Between SAISD's remaining inventory of portable buildings and 2020 bond funds allocated for phasing and swing space, SAISD will not need these (4) portables as swing space for the 2020 Bond Program. The sale price for the four (4) portable buildings is zero \$0.00 for all the portables. The consideration is the cost associated for removing the buildings from SAISD District property which is borne by UCISD. This cost includes providing insurance for any damage to SAISD's property as a consequence of the move.

- ❖ Purchase of Teachtown, a core-curriculum based on applied behavior analysis that provides students with moderate and severe disabilities including students with autism and other intellectual disabilities access to the general education curriculum. This purchase will be used for students in grades 1 through 12 District-wide.
- Purchase of Institute for Multisensory Education Dyslexia Professional Development and student/teacher materials.
- Purchase of Professional Development Modules on 504 and Dyslexia Awareness: Dyslexia Identification and Assessment for Informing Instruction; and Dyslexia Orton-Gillingham Approach.

- Purchase of Self Insured Employee Medical Plan-Third Party Administrator/Carrier and Network Options Insurance. This purchase will provide health insurance for District employees and their eligible dependents.
- ❖ Purchase of Self Insured Pharmacy Benefit Manager Services and Specialty Rx Program Insurance. This purchase will provide Pharmacy Benefits Services and Specialty Rx Program for District employees and their eligible dependents.
- Purchase of Fully Insured Employee Paid Voluntary Accident Plan Insurance. This purchase will provide accident insurance for District employees and their eligible dependents.
- ❖ Purchase of Fully Insured Employee Paid Voluntary Critical Illness Plan Insurance. This purchase will provide critical illness insurance for District employees and their eligible dependents.
- Purchase of Fully Insured Voluntary Vision Plan Insurance. This purchase will provide vision insurance for District employees and their eligible dependents.
- Purchase of Fully Insured Employee Paid Disability Plan Insurance. This purchase will provide disability insurance for District employees and their eligible dependents.
- Purchase of HSA and FSA Plan Administration. This purchase will provide health savings account, flexible spending account and dependent care accounts for District employees and their eligible dependents.
- ❖ Purchase of Fully Insured Employee Paid Legal Assistance. This purchase will provide Legal Insurance for District employees and their eligible dependents.
- Purchase of Fully Insured Voluntary Pet Insurance Plan. This purchase will provide Pet Insurance for District employee's pets.
- Purchase of COBRA Administration Insurance. This purchase will provide COBRA Insurance for District employees and their eligible dependents.
- Purchase of HVAC, building maintenance, and facility support repair, installation, operation supplies and equipment. This purchase will provide repairs for District-wide use on an "as needed" basis.
- Ratification for the purchase of pre-packaged backpacks with school supply kits. This purchase will provide back to school supplies to 20,000+ students in all school grades PK-12.
- ❖ Purchase of the replacement of the DX System, replace condenser and air handler. This purchase will be for Kelly E.S. new wing classrooms and hallway.

- ❖ Purchase of Fine Arts Color Guard Instructors. This purchase will design color guard programs to include the visual and musical component, work with marching band director and teach students color guard material across the SAISD High Schools on an "as needed" basis for District-wide use.

This purchase will provide yearly licenses for all campuses District-wide for all students to the Microsoft suite of tools weather they are on premises or engaged in district learning.
- Purchase of High School Clinical Counseling. This purchase will provide clinical counseling services to students registered in the 8 high schools on an "as needed" basis for District-wide use.
